### **Research (2010 – Present)**

I spend a minimum of 4 weeks a year conducting innovative anthropological and archaeological fieldwork in France and Belgium. My focus is on the relationship between human beings and the

material culture of recent conflict. Much of my work is conducted in hazardous subterranean landscapes beneath 20<sup>th</sup> century battlefields, demanding a close attention to team work and research professionalism. Skills essential to this work include:

- Designing cutting edge methodologies that combine both quantitative and qualitative techniques.
- Preparation and submission of grant and funding applications.
- Publication and dissemination of findings across multiple platforms, both academic and commercial.
- Comprehensive understanding of phenomenology, sensorial anthropology, material culture studies, cultural and social anthropology, archaeology, history and literature studies.
- Team work and the ability to operate under pressure, collegiate working practices, completion of complex risk assessments.
- Close working relationships with communities, landowners, local authorities and governments, as well as detailed liaison with police and emergency rescue services.
- Ability to work at depth in constricted 'live' conflict landscapes. The subterranean spaces I work in regularly suffer from a lack of oxygen and a constant danger of collapse, as well as the threat of unexploded ordnance.
